

Elenco Subfornitori INTESA che effettuano trattamento dei dati

Intesa uses certain subprocessors to support the provision of its services. These subprocessors are allowed to process customer data or personal data only to provide the services that Intesa has requested them to provide, and they are prohibited from using such data for any other purpose.

Section A:

In the case of categories of Consultant, IT Infrastructure and Help Desk subprocessors, these provide contract staff who work in close coordination with Intesa employees to support, manage and maintain all Intesa Services and in the course of this they may process personal data and of customers. In all these cases, customer data or personal data reside only in the Intesa facilities, on the Intesa systems and/or are subject to the policies and supervision of Intesa.
